IN THE SPOTLIGHT:

Social Work Leader, Barbara Dane

“Continuing Education in End-of-Life Care”

Barbara Dane has established an advanced professional training program at New York University Ehrenkranz School of Social Work for social work professionals involved in end of life care. The training program includes an End-of-Life Care Consortium of experienced professionals representing 10 New York City provider agencies, including Cancer Care, Gay Men’s Health Crisis, Calvary, Visiting Nurse Service of New York Hospice Care, NYU Palliative Care at the NYU Medical Center, and Chai Lifeline, a network of health support services of catastrophically ill Jewish children and their families.

The program began this fall with a curriculum that includes such topics as workers’ reactions and secondary trauma, the dying child and the bereaved child, spirituality, ethnicity and diverse populations, and ethical issues. The implications of developmental issues, cultural differences, and spiritual and religious diversity related to bereavement and mourning are highlighted. Besides coursework, the training fellows enrolled in the program complete a one-day field visit in a setting outside their current agency and a special field project that will enhance the practice, policy or research in their agency. They are also assigned a mentor who assists them in planning their special project.

Fellows involved in the training program gain valuable social networks and knowledge. Too often professionals involved in end of life care are isolated from one another and their colleagues are uncomfortable dealing with issues of death and dying. According to one fellow, Alissa Sandler, “It’s a great opportunity to meet and interact with peers. Fieldwork can be very isolating, especially when dealing with grief and bereavement.”

Awards, Grants and Presentations

November 2000, Baltimore, Maryland: Terry presented at a conference organized by Susan Blacker, titled "Social Work and End of Life Care Symposium: Clinical Practice in Palliative Care." She spoke on "Pain and Symptom Management: A Multidimensional Perspective."

Iris Cohen, LICSW, recently visited Melbourne, Australia, as the International Scholar chosen for the Boston/Melbourne Social Work Exchange from Beth Israel Deaconess Medical Center in Boston. Iris spent a month learning about the systems and methods of care related to both oncology social work and palliative care in Melbourne. She had the opportunity to visit several inpatient palliative care units as well as community-based palliative care and consultation services.

ACCESS presented an all day educational program on Dec 15, 2000, to a group of 13 health care providers that included physicians, nurses, social workers, and chaplains. This was the first part of a three-part training called Multicultural End-of-Life Care. The training was held at Laguna Honda Hospital in San Francisco. This training consisted of two modules. **Norma del Rio, MSW, of the Institute for Multicultural Research and Social Work Practice** presented the first module titled "A Framework for Multicultural End-of-Life Care." and a nurse practitioner presented the second module titled "Symptom Management from a Multicultural Perspective". Each module was three-hours long and continuing education units were offered to the attendees.

New in Print and Media

Walsh-Burke, K. and Scanlon, P. (2001). *Beyond Reviving Ophelia: Groups for Girls 12-14 and the Women who Care about Them.* *Social Work with Groups*, *23(1)*: 71-81.

This article discusses an innovative multigenerational psychoeducational group designed for pre adolescent and adolescent girls and the adult women who care about them. The program was developed by two social workers, who are also mothers of adolescent daughters, and is based on a strengths and empowerment approach. The purposes of the group are to foster an alliance between girls and adult women, to increase awareness of the pressures girls experience in contemporary culture and to teach strategies that support girls in developing and maintaining authentic selves.

The program has been offered in middle schools, high schools and community social service agencies. Qualitative data have been gathered from approximately eighty girls and women who have participated in the group programs. These indicate that the program is effective in facilitating communication among girls and women, increasing a sense of mutual support, and helping girls and women to become more critical consumers of mass media.

Identifies, recruits, and maintains a cadre of experts. Collaborates with Divisions and key national staff and volunteers on all related issues.
